### New WOTUS Rule Released

On January 23, 2020, the U.S. Environmental Protection Agency (EPA) and Department of the Army released the pre-publication version of the Navigable Waters Protection Act: Waters of the United States Definition, replacing the 2015 Clean Water Rule. The new rule will become effective 60 days after publication in the Federal Register. The pre-publication version can be found [here](#). 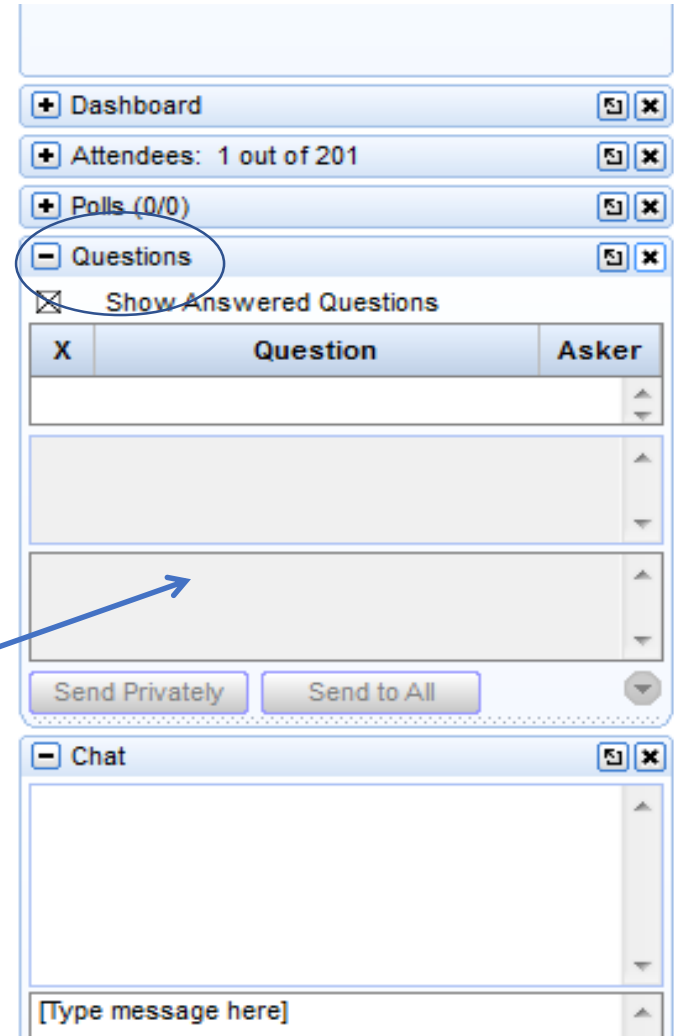

# Certificates of Participation

## Who can get Certificates of Participation?

You must be a participant during the entire live webinar presentation.

You must have registered under your own name or if part of a group, verify your participation.

## Using *ClassMarker* to Download your Certificate of Participation

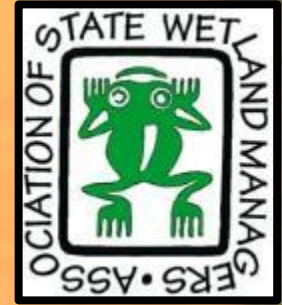
