In Memorium: Roy R. "Robin" Lewis III



The world lost one of its biggest wetland advocates, [Roy R. "Robin" Lewis III](#) on September 24th. For more than four decades, Robin set a standard of quality and commitment that earned the respect of clients, regulators and colleagues alike. He was among the first in the U.S. to successfully restore damaged wetlands, and was a leader in the vanguard of progress in habitat restoration and creation. Robin designed more than 125 completed wetland restoration or creation projects in the

United States, Puerto Rico and the U.S. Virgin Islands. He earned a well-deserved reputation among his peers as a leader in ecosystem management and restoration around the world. ASWM worked with Robin for over 25 years. He was one of the chapter authors of "Wetland Creation and Restoration: Status of the Science" in 1990 edited by previous ASWM Executive Director, Dr. Jon Kusler and Dr. Mary Kentula. This seminal publication set the standard for understanding the science of wetlands restoration and creation for many years, but this past evening, Robin was

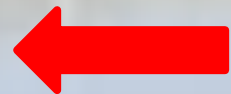
